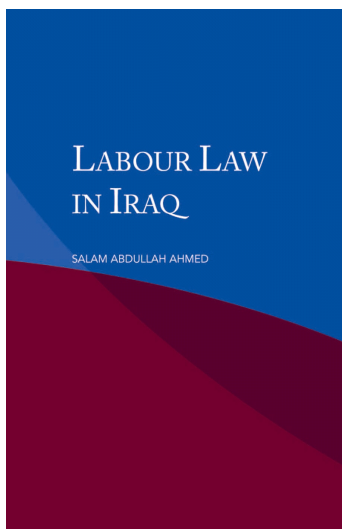


## Labour Law in Iraq
